

ORDINANCE NO. 2024-02

AN ORDINANCE OF THE VILLAGE OF MALCOLM, LANCASTER COUNTY, NEBRASKA, TO AMEND SECTION 6-207 RELATING TO THE IMPOUNDMENT OF ANIMALS; TO AMEND SECTION 7-101 RELATING TO THE DEMOLITION OF STRUCTURES; TO PROVIDE FOR PUBLICATION; AND TO PROVIDE AN EFFECTIVE DATE

**BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF MALCOLM, NEBRASKA:**

**Section 1.** Section 6-207 of Village Code is hereby amended as follows:

**6-207 Animals; Impounding**

Animals maintained unlawfully or found running at large within the Municipality may be ~~captured~~ impounded by the official in charge of animals ~~and killed or confined~~ in the manner prescribed for dogs.

**Section 2.** Section 7-101 of Village Code is hereby amended as follows:

**7-101 Fires; Preservation Of Property**

The Fire Chief, or any officer in charge of the Fire Department, shall have the authority and power to cause the removal of property whenever it shall become necessary for the preservation of more valuable property, the protection of human life, or to prevent the spreading of fire to adjoining property. The Fire Chief may direct the Firemen to remove any building, structure, or fence for the purpose of checking the progress of any fire. ~~The Fire Chief shall have the authority to blow up, or cause to be blown up, with explosives, any building or structure during the progress of a fire for the purpose of checking the progress of the same.~~

**Section 3.** Any conflicting provisions in the Malcolm Village Code or other ordinances are hereby repealed.

**Section 4.** This ordinance shall be published in book or pamphlet form and posted in three (3) public locations in the Village of Malcolm. This Ordinance shall take effect and be in full force from and after its passage, approval, and publication as provided by law.
