## ORDINANCE NO. 2025-01

AN ORDINANCE OF THE VILLAGE OF MALCOLM, LANCASTER COUNTY, NEBRASKA, TO AMEND SECTION 6-202 TO ALLOW ONE MINI-PIG PER HOUSEHOLD; TO PROVIDE FOR PUBLICATION; AND TO PROVIDE AN EFFECTIVE DATE

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF MALCOLM, NEBRASKA:

Section 1. Section 6-202 of Village Code is hereby amended as follows:

## 6-202 Animals; Banned From Municipality; Exceptions; Mini-Pigs

- A. Except as provided herein, it-It shall be unlawful for any person to keep or maintain within the corporate limits any horse, mule, sheep, cow, goat, swine or other livestock except such livestock as are within the said limits temporarily for exhibition purposes, or are kept in sanitary and enclosed areas at least two hundred (200) feet from any habitable structure owned by any person or business. Nothing herein shall be construed to permit, or sanction a commercial feed lot.
- B. The keeping or maintaining of mini-pigs (a small breed animal of any subspecies of Sus scrofa domesticus, including the Vietnamese potbellied pig or American Mini-Pig) within corporate limits is authorized under the following conditions.
  - 1. No more than one (1) mini-pig shall be allowed per household.
  - The maximum weight for mini-pigs shall be 100 pounds.
  - 3. All mini-pigs shall be spayed or neutered. The breeding of mini-pigs within corporate limits is prohibited.
  - 4. All mini-pigs shall be vaccinated against rabies and other transmissible diseases common to the species.
  - 5. All mini-pigs shall be registered with and licensed by the Village of Malcolm on an annual basis. The registration fee may be set by separate resolution.
  - 6. All mini-pigs shall be kept in an enclosed pen or structure. Such enclosure shall be secure and maintained in a clean condition, free of accumulated refuse, manure, and debris.
  - 7. The owner of any mini-pig causing damage to property or persons shall be liable for such damages to the person(s) injured.
  - 8. Any person who violates any provision of this section shall forfeit their mini-pig license and shall not be eligible to obtain a license in the future. The owner of any mini-pigs maintained in violation of this section may be assessed the costs for boarding, care, and disposal of said animals.

**Section 2.** The initial registration fee for mini-pigs shall be \$25.00 per year. The Clerk shall update the Master Fee Schedule accordingly. The registration fee may be updated from time to time by resolution.

**Section 3.** Any conflicting provisions in the Malcolm Village Code or other ordinances are hereby repealed.

**Section 4.** This ordinance shall be published in book or pamphlet form and posted in three (3) public locations in the Village of Malcolm. This Ordinance shall take effect and be in full force from and after its passage, approval, and publication as provided by law.
