

ORDINANCE NO. 25-03

AN ORDINANCE FOR THE VILLAGE OF MALCOLM, NEBRASKA, TO ADOPT THE WELLHEAD PROTECTION PLAN FOR THE VILLAGE OF MALCOLM, NEBRASKA, AS PREPARED BY LRE WATER FOR THE VILLAGE OF MALCOLM; TO PROVIDE FOR THE REPEAL OF ORDINANCES INCONSISTENT HEREWITH; TO PROVIDE WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT; AND TO PROVIDE FOR THE PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM.

BE IN ORDAINED BY THE VILLAGE CHAIRMAN AND THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF MALCOLM, NEBRASKA:

Section 1: Definitions. Wellhead Protection Area means the surface and subsurface area surrounding a public water supply well or wellfield, supplying a public water supply system, through which contaminants are reasonably likely to move toward and reach such water well or wellfield.

Section 2. The Village Board designates a Wellhead Protection Area for the purpose of protecting the public water supply system. The boundaries of the Wellhead Protection Area are based upon the delineation map published by the Nebraska Department of Environment and Energy on December 2024. The boundaries of the Wellhead Protection Area are:

South Half of the South Half (S1/2 S1/2 of Section Sixteen (16), Township Eleven (11) North, Range Five (5) East of the Sixth Principal Meridian, Lancaster County, Nebraska.

Southeast Quarter (SE1/4) and the Southwest Quarter (SW1/4) of Section Seventeen (17), Township Eleven (11) North, Range Five (5) East of the Sixth Principal Meridian, Lancaster County, Nebraska.

Northeast Quarter (NE1/4), Northwest Quarter (NW1/4), Southwest Quarter (SW1/4), and the Southeast Quarter (SE1/4) of Section Twenty (20), Township Eleven (11) North, Range Five (5) East of the Sixth Principal Meridian, Lancaster County, Nebraska.

Northeast Quarter (NE1/4), Northwest Quarter (NW1/4), Southwest Quarter (SW1/4), and the Southeast Quarter (SE1/4) of Section Twenty-one (21), Township Eleven (11) North, Range Five (5) East of the Sixth Principal Meridian, Lancaster County, Nebraska.

Section 3. That the Wellhead Protection Plan for the Village of Malcolm, Nebraska, dated January 2025, prepared by LRE Water for the Village of Malcolm, approved by the Malcolm Village Board, is hereby adopted as the Wellhead Protection Plan for the Village of Malcolm, Nebraska. The Wellhead Protection Plan was based upon the Wellhead Protection Area as described in Section 2.

Section 4. That a copy of the Wellhead Protection Plan and a map of the Wellhead Protection Area for the Village of Malcolm, Nebraska, are on file and shall be kept in the office of the Village Clerk.

Section 5. That all Ordinances previously adopted by the Village Board of the Village of Malcolm, Nebraska, which are inconsistent and in conflict herewith this Ordinance are hereby repealed and without further force of effect.

Section 6. That this ordinance shall be in full force and take effect from and after its passage, approval, and publication as required by law.
