#### **RESOLUTION NO. 2023-03**

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MALCOLM, LANCASTER COUNTY, NEBRASKA, TO UPDATE AND AUTHORIZE THE PLACING OF STOP SIGNS, RESTRICTED PARKING, OR OTHER TRAFFIC SIGNS WITHIN CORPORATE LIMITS

WHEREAS Section 5-216 of the Malcolm Village Code states:

The governing body may, by resolution, provide for the placing of stop signs, restricted parking, or other signs, signals, standards, or mechanical devises in any street or alley for the purpose of regulating, or prohibiting traffic and parking thereon. Such resolution shall describe the portion of the street or alley wherein traffic is to be regulated or prohibited; the regulation or prohibition; the location where such sign, signal, standard or mechanical device shall be placed; and the hours when such regulation or prohibition shall be effective. It shall be unlawful for any person to fail, neglect, or refuse to comply with such regulation, or prohibition. The placement of such regulatory sign shall be prima facie evidence of the restricting resolution.

**WHEREAS** the Village has compiled a list of all existing traffic signs, which is attached and incorporated as Exhibit A, and finds such traffic signs are necessary to the welfare and safety of the community;

# NOW THERFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF MALCOLM, NEBRASKA:

- The traffic signs set forth in Exhibit A are hereby authorized and approved.
- 2. Any person who shall fail, neglect, or refuse to comply with any such traffic sign may be subject to citation and prosecution under village ordinance or state statute accordingly.
- 3. This Resolution shall be effective after its approval, passage, and publication according to law.
